Announcement of adjusted expenses¹ and investments budgets

BM&FBOVESPA S.A. – Bolsa de Valores, Mercadorias e Futuros (“Company”) announces the adjusted expense (“OPEX”) budget and reviews the investments (“CAPEX”) budget, as follows:

- (i) Adjusted expense budget for 2014: interval between R\$595 million and R\$615 million;
- (ii) Investment budget revision for 2014: new interval of R\$230 million to R\$260 million, in comparison with the previous interval between R\$170 million and R\$200 million, announced in December 11, 2012; and
- (iii) The investments budget for 2015: interval between R\$190 million and R\$220 million.
