**MINUTES OF THE ANNUAL GENERAL SHAREHOLDERS' MEETING HELD ON
MARCH 30, 2015**

DATE, TIME AND PLACE. On March 30, 2015, at 11 a.m., exceptionally on this occasion held outside the registered office of the Company, at Rua XV de Novembro, 275, in the City of São Paulo, State of São Paulo.

CALL NOTICE. Call notice published on February 27, February 28 and on March 3, 2015, in the Official Gazette of the State of São Paulo (pages 154, 60 and 156, respectively) and in the *Valor Econômico* newspaper (pages A10, B6 and B13, respectively).

PUBLICATIONS. The management's report and the financial statements as of and for the year ended December 31, 2014, and related notes, in conjunction with the independent auditors' report prepared by Ernst & Young Auditores Independentes S.S. and the Audit Committee report have been published on February 11, 2015, in the Official Gazette of the State of São Paulo (pages 61 through 74) and in the *Valor Econômico* newspaper (pages A15 through A22).

ATTENDANCE. Attendance by holders of record representing over thirty-eight percent (38%) of the voting shares of stock, as per signatures affixed in the Shareholders' Attendance List in the proper register. This constituting a quorum, the Chairman convened the annual meeting for shareholders to consider items I-1, I-2, I-3 and I-4 of the agenda, whereas clarifying it is insufficient quorum for shareholders to hold the extraordinary meeting, such that a second call notice will be published, pursuant to paragraph 6 of article 12 of the bylaws, for shareholders to consider at a later date the proposals under item II-1 of meeting agenda. Mr. Luiz Nelson Guedes de Carvalho, Coordinator of the Audit Committee of the Company and Mr. Flavio Serpejante Peppe, representing Ernst & Young Auditores Independentes S.S., and officers of the Company were also present.

PRESIDING OFFICERS. Chairman: Mr. Pedro Pullen Parente; Secretary: Mr. Edemir Pinto; Mr. Luiz Nelson Guedes de Carvalho, Coordinator of the Audit Committee of the Company; Mr. Daniel Sonder, Chief Financial, Corporate Affairs and Investor Relations Officer of the Company; Mrs. Maria Elsa Alba Bernhoeft, Communication, Human Resources and Education Officer of the Company; Mr. Roberto Augusto Belchior da Silva, General Counsel of the Company; and Mr. Paulo Cezar Aragão, the Company's external legal counsel.

ORDER OF BUSINESS. (1) To receive the management's report, and to receive, review and judge the financial statements as of and for the year ended December 31, 2014; (2) To consider the proposal on allocation of net income for the year ended December 31, 2014 and the dividends payable; (3) To elect the members of the Board of Directors; and (4) To

set the aggregate compensation payable in 2015 to members of the board of directors and the executive officers.

DECISIONS. Following an authorization for these minutes to be drawn up in summary form and published without the names and signatures of attending shareholders, as permitted under article 130, paragraphs 1 and 2, of Brazilian Corporate Law (Law No. 6,404/76, as amended), the decisions set forth below were taken with abstentions from those legally precluded from voting:

(1) By unanimous affirmative vote, the shareholders approved the management's report and the financial statements as of and for the year ended December 31, 2014, and related notes and the independent auditors' report prepared by Ernst & Young Auditores Independentes S.S.

(2) By unanimous affirmative vote, the attending shareholders approved the proposal to allocate the amount of net income for the year ended December 31, 2014, amounting to R\$ 977,053,025.26 as follows:

(i) R\$ 781,642,000.00 to distribution by way of dividends. Accordingly, after offsetting the aggregate of R\$ 977,053,025.26 against interim distributions to shareholders over the course of 2014, in the amounts of R\$ 595,701,000.00 paid by way of interim dividends, the total net balance of R\$ 185,941,000.00 will be distributed and paid as dividend. As currently estimated, the distribution of this net balance would correspond to payment of R\$0.10316344 per share (which amount may change as a result of both treasury stock being reissued for fulfillment of stock options exercised pursuant to the Company's stock option plan, and repurchases carried out under the Company's Share Buyback Program). The dividend payment date has been set for April 28, 2015 and the book closure date determining the ownership structure pursuant to which holders of record will be entitled to dividends will be April 15, 2015. Thus, BM&FBOVESPA stocks will trade cum-dividend up until and including April 15, 2015, and starting from April 16, 2015, will trade ex-dividend, and

(ii) R\$ 195,411,025.26 to the Bylaws reserve for investments and the special safeguard funds and clearing and settlement mechanisms adopted by the Company.

(3) By a majority affirmative vote, and in accordance with the Bylaws, the attending shareholders elected the persons identified below to serve on the Board of Directors of the Company for a two-year term ending at the date of the annual shareholders' meeting that convenes to judge the 2016 financial statements. The directors now elected will take office upon presenting and signing the (i) instrument of investiture drawn up in the proper register, which must contain the statements required under applicable law and regulations; (ii) no-liability statement, for the purposes of article 147 of Brazilian Corporate Law (Law No. 6,404/76) and article 2 of Brazilian Securities Commission (CVM) Ruling No. 367/02; and (iii) statement regarding ownership of securities issued by the Company, its subsidiaries or other companies within the group, as required under article 157 of Brazilian Corporate Law.

(4) By a majority affirmative vote, the attending shareholders set at an amount up to R\$ 8,314,234.72 the aggregate annual compensation attributable to members of the board of directors and at an amount up to R\$ 37,558,975.09 the aggregate annual compensation attributable to the executive officers.

CLOSING. There being no further business to transact, these minutes were drawn up, and subsequently read, found to conform, approved and signed by all shareholders in attendance. São Paulo, March 30, 2015.
