**MINUTES OF THE ANNUAL AND EXTRAORDINARY SHAREHOLDERS  
MEETINGS  
HELD ON APRIL 28, 2017**

**DATE, TIME, AND PLACE:** On April 28, 2017, at 11:00 a.m., in the registered office of BM&FBOVESPA S.A. – Bolsa de Valores, Mercadorias e Futuros (“Company” or “B3”) located at Praça Antonio Prado, No. 48, in the City of São Paulo, State of São Paulo.

**CALL NOTICE:** Call notice published on March 30 and 31, 2017, and April 1, 2017, in the Official Gazette of the State of São Paulo (pages 276, 3 and 3, respectively), and on March 30 and 31, 2017, and April 3, 2017, in the newspaper Valor Econômico (pages A10, A8, and A10, respectively).

**PUBLICATIONS:** Annual Management Report, Financial Statements relating to the fiscal year ended December 31, 2016, together with the Accompanying Notes, the Report issued by Ernst & Young Auditores Independentes, and the Audit Committee Report published on February 20, 2017 in the newspaper Valor Econômico (pages B11 to B17), and on December 21, 2017, in the Official Gazette of the State of São Paulo (pages 100 to 113).

**ATTENDANCES:** Shareholders representing more than 59% (fifty nine per cent) of the total voting capital stock of the Company attended the meeting, as evidenced (i) by their signatures in the “Shareholders Attendance Register” and (ii) by the remote vote forms validly received through the Central Securities Depository of B3, the bookkeeping agent of the shares issued by the Company, or directly by the Company, according to the CVM (Brazilian Securities Commission) regulations. Since there was sufficient quorum, the Chairman commenced the Annual Shareholders Meeting and Extraordinary Shareholders Meeting for the purpose of resolving the items II-1, II-4 and II-5 of the Agenda and clarified that in view of the absence of a quorum for resolve the item II-2 and II-3 of the Agenda, the Company will announce another date for the Extraordinary Meeting to convene on second call to decide on these both topics of the Agenda. Members of the Management of the Company, and Mr. Eduardo Wellichen, representative of Ernst & Young Auditores Independentes, were also present at the meetings.

**RESOLUTIONS:** After reading the consolidated voting map regarding the votes cast through remote vote forms, which was available for consultation by the attending shareholders pursuant to paragraph 4, article 21-W, of CVM Ruling No. 481/2009, the following resolutions have been made, with the abstentions permitted by law, and the drawing up of these minutes as a summary and its publication without the signature of the shareholders were approved, as permitted under article 30, §§ 1 and 2, of Law No. 6404/76:

#### **I – At the Annual Shareholders Meeting:**

(1) To approve, by majority of the attending shareholders, with 88.67% of favorable votes, represented by 1,072,220,975 shares; 0.03% of contrary votes, represented by 284,880 shares; and 11.31% abstentions, representing 136,712,761 shares, the accounts rendered by the managers and the Financial Statements for the fiscal year ended December 31 2016, with the Accompanying Notes and the report of Ernst & Young Auditores Independentes, registered abstentions of the managers in this item of the Agenda.

(2) To approve, by unanimity of the attending shareholders, with 99% of favorable votes, represented by 1,197,139,716 shares; 0,00% of contrary votes; and 1% abstentions, representing 12,078,900 shares, the proposal of allocation of the net income for the fiscal year ended December 31 2016, corresponding to R\$1,446,263,098.70, as follows:

(i) R\$900,000,000.00 as mandatory dividends, and said amount was already paid to the shareholders by means of interest on equity relating to the year 2016; and

(ii) R\$546,263,098.70 to integrate the mandatory reserve for investments and composition of funds and safeguard mechanisms of the Company.

(3) To approve, by majority of the attending shareholders, with 98.29% of favorable votes, represented by 1,188,927,519 shares; 0.06% of contrary votes, represented by 674,608 shares; and 1.66% abstentions, representing 20,016,489 shares, that the Board of Directors consist of

up to 13 members or, if approved by the Extraordinary Shareholders Meeting convened to be held as of the date hereof the amendment to the transitory provision of the Bylaws to increase the maximum number of members of the Board of Directors from 13 to 14, that the Board of Directors consist of 14 members.

The members of the Board of Directors elected herein shall take office upon submission: (i) of the respective investiture instrument drawn up in proper book, containing statements in compliance with the law and the regulation in effect; (ii) of the statement of good standing, for the purposes of Article 147 of Law No. 6404/76, and Article 2 of CVM Ruling No. 367/02; and (iii) of the statement of any securities issued by the Company that may be held by them and its controlled companies or companies of the same business group, pursuant to Article 157 of Law No. 6404/76, and Mr. José Roberto Machado Filho shall only take office as soon as the amendments to the bylaws referred to in item II.3.(j) of the Agenda are approved by the Brazilian Securities Commission (CVM) within the scope of its powers to previously approve amendments to the bylaws of administrators of organized markets under Ruling No. 461/2007.

## **II – At the Extraordinary Shareholders Meeting:**

(4) To ratify, by majority of the attending shareholders, with 96.6574% of favorable votes, represented by 1,177,966,992 shares; 0.0003% of contrary votes, represented by 3,200 shares; and 3.3244% abstentions, representing 40,506,656 shares, the payments made to the management in the year 2016 in the amount of R\$1,360,218.02, according to the Management Proposal.

(5) To approve, by majority of the attending shareholders, with 62.30% of favorable votes, represented by 788,580,055 shares; 29.50% of contrary votes, represented by 329,994,416 shares; and 8.20% abstentions, representing 99,902,377 shares, the fixing of the annual global remuneration of the managers for the current fiscal year, in the amount of up to R\$12,494,000.00 for the Board of Directors and R\$154,345,000.00 for the Executive Board according to the terms of the Management Proposal.
