## NOTICE TO THE MARKET

Clarification on news article (Ref.: Official Letter 228/2018/CVM/SEP/GEA-1)

In reference to Official Letter 228/2018/CVM/SEP/GEA-1, transcription attached, which requests clarifications on a news article published on June 08, 2018, in the newspaper Valor Econômico, Finance section, under the headline: "B3 partnership in China", particularly on the statement transcribed below:

✓ B3 announced a partnership with China Invest Information Services (CIIS), a
subsidiary of the Shanghai Stock Exchange. The agreement provides for CIIS to
act as the official market data distributor and administrator for B3 in mainland
China. In a note, Gilson Finkelsztain, CEO of B3, stated that "the Shanghai Stock
Exchange is one of the most important in the world and Asia is part of B3's longterm strategy".

B3 confirms the veracity of the above statement. Although we consider this partnership important for the distribution of Brazilian market data in China, we do not consider this as a Material Fact, under the terms of the regulation, as we do not expect any material impact on our revenues or results in the short or medium term. In the last 12 months, revenues from the distribution of market data accounted for 2.4% of our total revenues and the addition of new customers resulting from such partnership will represent a fraction of that percentage.

Subject: Request for clarification on news article.

Dear Sir,

1. In reference to news published, on this date, in the newspaper Valor Econômico, Finance section, under the headline "Highlights - B3 partnership in China", which contains the following affirmations:

B3 announced a partnership with China Invest Information Services (CIIS), a subsidiary of the Shanghai Stock Exchange. The agreement provides for CIIS to act as the official market data distributor and administrator for B3 in mainland China. In a note, Gilson Finkelsztain, CEO of B3, stated that "the Shanghai Stock Exchange is one of the most important in the world and Asia is part of B3's long-term strategy".

2. In light of this, we request a statement from the company regarding the veracity of the news article, and if confirmed, please explain the reason the subject was not considered as a Material Fact, and also comment other facts that are considered important on the matter.



- 3. We also remind our obligation set forth in the sole paragraph of article 4 of CVM Instruction 358/02, which is to inquire the Company's management and controlling shareholders, as well as all other persons with access to relevant facts, with the purpose of ascertaining whether they have knowledge of information that should be disclosed to the market.
- 4. Explanations must be sent through the Empresa.net System, category: Comunicado ao Mercado (Notice to the Market), type: Esclarecimentos sobre questionamentos da CVM/B3 (Clarification on CVM/B3 inquiries), subject: Notícia Divulgada na Mídia (News Disclosed in the Media), in which the transcript of this letter must be included.
- 5. We point out that, according to the Superintendence of Corporate Relations and its legal attributions, and based on article 9, item II of Law 6,385/76 and CVM Instruction 452/07, a penalty of R\$ 1,000.00 (one thousand reais), without prejudice to other administrative sanctions, will be imposed for failure to comply with the requirements contained in this letter, exclusively by e-mail, by June 11, 2018, which is provided for in the sole paragraph of article 6 of CVM Instruction 358/02.
